RE: Art Show & Sale – NEW VENUE!

July 3 & 4, 2015: 9:00 AM – Gates Open. Main activities begin around 10:00 AM. All scheduled events will go on, rain or shine, as provisions are made for major attractions to be under cover in the event of rain.

The **ART SHOW & SALE** will be held in a building to be identified as the **Ми Пазо ~ We Are...Together** Venue. (This venue will be in the building known as the Vegreville Skating Rink/Arena. We have room for approximately 8 artists. This venue will allow for you to display and sell your art.

NOTE! For our 2015 Ukrainian Pysanka Festival, there is ***no charge*** for admission at the main gate! All venues (except Grandstand Show and Evening Dance) will be ***FREE*** to the public.

SPACE in the ART SHOW & SALE venue will consist of the following:

- Approximately 15 foot indoor space
- Tables and chairs are available in this venue, and will be shared amongst the artists as they see fit

SET UP: Thursday, July 2nd, into late PM or Friday, July 3rd, early AM, before 10:00 am (Remember that Friday AM is the first day of the Festival, so you want to be ready by 10:00 AM). There will be no vehicles in the venue during business hours. All vendors will stay open until closing time.

	SATURDAY July 4, 2015	10:00 AM – 7:00 PM

APPLICATION DEADLINE: Applications will be accepted on a first-come basis. Fully paid applications will be given priority in the order that they are received. The committee reserves the right to select applications based on type of art and the time of receipt.

ART SHOW & SALE CONTRACT PROVISIONS

1. Rental fee is for the use of space only.
2. At no time will electrical services used in the indoor booth exceed the capacity of the power provided to that space.
3. Extension cords, lights, props are the responsibility of the vendor, which must be confined to the space rented.
4. As a good neighbour, each Artist's display shall avoid blocking the view of the neighbour's booth.
5. There shall be no subletting, re-assigning or transferring of the rental space to a third party.
6. Space is to be used only for the sale of art as approved by the Association from the list submitted in the application. The Festival must approve any amendments to the list.
7. The Association reserves the right to limit NOISE or anything else that distracts from the spirit of the market.
8. For security, the indoor facility will be locked during non-business hours.
9. The vendor shall be liable for any damage caused to the facility or props by the vendor.
10. The vendor shall be responsible for any insurance for their art and displays. **THE ASSOCIATION DOES NOT ASSUME ANY RESPONSIBILITY FOR GOODS LOST OR DAMAGED WHILE IN THE DISPLAY AREA OR IN TRANSIT TO OR FROM IT.**
